One of my resolutions is to ask myself every day "How can I have more fun?" Perhaps this is one I can make!


Your Board has been hard at work to make this year successful.

#### NEW MEETING TIME AND LOCATION


By now you should have received the news that we will be meeting in a new location starting with our January 18 meeting.

In an agreement with the Allen Arts Alliance, we will be at their Art gallery space in <u>Watters</u> <u>Creek Mall</u>, known as <u>Blue House Too</u>. The new space is light, airy and beautiful with lots of electrical plugs and reliable heating and a/c.


